- It's assessment season! Multiple assessments are currently open across varying programs and grade bands. Spring assessment training and testing windows are almost underway, as well. Our District Assessment Coordinator continues to support schools as a liaison between assessment vendors and school personnel. We are here to support you!
- As we are actively working to begin the wind-down of the 23-24 school year, we are also starting to plan for the 24-25 school year. Comprehensive Needs Assessments for future budget/federal activities should be underway at the school level to ensure all approved activities directly impact student achievement in the classroom. Reach out to the S&I Team for support as needed.
- The PCSD Board of Trustees approved the new PCSD accountability system, styled the AFO Index. A PDF slide-deck was shared with schools on Monday, February 26<sup>th</sup> via e-mail. A virtual session will be scheduled for the spring with school leaders to discuss the Index and answer any questions.
- The PCSD appreciates schools' hard work in providing data for the federally required CRDC data collection.
- Please note that Climate Surveys for teachers, students, and parents are open. Schools need 80% participation rates from teachers and students or the indicator rating will be lowered one level.
- There are changes to Graduation Rate Reporting. More information will be forthcoming as the SCDE clarifies the process.
